



Article: *Elohim's Sacred Lineage: Guided in Truth and Purity*

Introduction

Elohim, a divine team spirit of Gods and Goddesses (John 4:24, Genesis 1:27), created humanity, male and female, in Their image to reflect Their glory. Gabriel, the *Elohim* of Abraham, Isaac, and Jacob, sent Jesus to teach the Keys of Knowledge (Luke 11:52), a code and encryption establishing authenticity and a code of conduct that organizes society and raises civilizations. As a “peculiar people” (1 Peter 2:9, *genos eklekton*), descendants of Abraham and Sarah are set apart for covenant fidelity, marked by distinct features like light hair and eyes. *Elohim* prescribes religion, diet, lifestyle, and mating to preserve this sacred bloodline, warning against mixing to maintain Their perfect design (Acts 17:26). From the sons of God in Genesis to Gabriel’s role with Mary, Noah’s repopulation, and Babylon’s scattering, *Elohim*’s truth shapes Their people. All nations worship at Zion, recognizing their unique races, united in Christ (Galatians 3:28–29).

Elohim: Spirit, Gods, and Goddesses

Elohim is spirit, worshipped in spirit (words) and truth (John 4:24), embodied in men and women like Moses (Exodus 7:1), Jesus (John 1:14), and believers as *elohim* (Psalm 82:6). Their Words, the Holy Bible, are proven true by the Keys of Knowledge (Luke 11:52), a divine code authenticating Their guidance and establishing a code of conduct for societies and civilizations. Jesus, with white hair like wool (Revelation 1:14–16), wields the twoedged sword of *Elohim*’s Word (Hebrews 4:12), while Gabriel (Daniel 8:16, 9:21) delivers truth, speaking face-to-face with Moses as *Elohim* (Exodus 33:11). Jesus and Gabriel, Lord Gods in a divine lineage, serve the unseen Father (John 1:18), forming a chain of command with Michael. They are together, except at the Crucifixion

(Matthew 27:46, “Why hast thou forsaken me?”), guiding humanity through prophetic poetry and truth.

Sons of God and Mating Parameters

In Genesis 6:2–4, the sons of God (*bene ha-elohim*), divine beings from other stars and planets, defied *Elohim*’s guidance by mating with human females, producing Nephilim and fueling pre-Flood corruption (Genesis 6:5–7). This violation shows *Elohim*’s strict mating parameters to preserve covenant purity. Similarly, Gabriel, a Lord God, visited Mary, overshadowing her through physical contact (Luke 1:35), as conception requires touching, refuting the Roman Catholic claim of a non-physical virgin birth. Mary’s child, Jesus, born of Gabriel’s divine lineage, fulfills *Elohim*’s plan, with Gabriel present at the tomb (John 20:12, one of two angels). These events underscore *Elohim*’s mating guidance, as mixing risks covenant loss and alters the sacred DNA code of Abraham’s lineage.

Separation and Covenant Purity

Elohim commands separation to preserve Their chosen lineage. In Exodus 12:38, a “mixed multitude” (*erev rav*) left Egypt with Israel but was separated to maintain covenant purity (Nehemiah 13:3, “they separated from Israel all the mixed multitude”). Ezra 9:2 warns against intermarriage with foreign nations, as the “holy seed” mingled with idol-worshippers, risking covenant loss. Deuteronomy 7:3–4 forbids marrying Canaanites, lest they turn Israel’s heart from *Elohim*. Mixing alters the DNA code, diluting the distinct features (light hair/eyes) of Abraham’s line, a “peculiar people” (1 Peter 2:9). Only these descendants move to Zion as Jews, while mixed individuals join the Church or Islam, and all nations worship at Zion, embracing their unique races (Revelation 7:9).

Noah’s Family and the Nations

After the Flood, Noah’s sons—Shem, Ham, Japheth—repopulated the earth (Genesis 10:32), founding civilizations in the Middle East (Shem: Hebrews), North Africa (Ham: Egypt), and Europe (Japheth: Celts). Their diverse traits, like *admoni* (red hair, fair skin; David, 1 Samuel 16:12) and *shechorah* (tanned beauty; Song of Solomon 1:5), reflect *Elohim*’s perfect design (Acts 17:26). At Babylon, humanity refused to scatter, seeking one tongue and nation (Genesis 11:4). *Elohim* confounded their languages and scattered them (Genesis 11:8–9), creating distinct races with unique features, supported by archaeological evidence (e.g., red-haired Ramesses II of Ham’s line, diverse phenotypes in Mesopotamian art). Abraham’s lineage, a “holy seed” (Ezra 9:2), stands apart with light hair/eyes, marking their covenant calling.

Preserving the Peculiar People

Elohim guides Their people through religion (Deuteronomy 6:5), diet (Leviticus 11), lifestyle (Proverbs 14:23), and mating (Deuteronomy 7:3–4) to preserve Abraham's lineage. Mixing, as with the sons of God (Genesis 6:2–4) or idol-worshippers (Ezra 9:2, Exodus 12:38, Nehemiah 13:3), risks covenant loss and alters the DNA code, which *Elohim* designed as perfect for each race (Acts 17:26). Abraham's line, with distinct features, is identified by their anointed appearance, unlike other nations who embrace their own beauty. All races are perfect, and preserving them honors *Elohim's* creation, as mixing dilutes the sacred code of Their chosen.

Gabriel's Authority and Prophetic Poetry

In Revelation 2, Jesus holds the seven stars (church angels, Revelation 1:20), representing Gabriel's authority to judge churches and bar entry to the kingdom (Revelation 2:5). This poetic imagery, blending truth and the Keys of Knowledge, reflects *Elohim's* guidance through Gabriel, who delivers Their Word (Daniel 8:16). As a man today embodies this authority, Abraham's lineage continues to teach truth, guiding all nations to Zion in unity (Galatians 3:28–29).

Just as the Keys of Knowledge are a divine code for society, DNA is a genetic code for humanity, preserved through *Elohim's* mating guidance to maintain distinct, perfect races.
